The expansion will support Norwood's strategic goal of producing 35 million parts per year.

Commenting on his appointment, Mr. Kircher said, "It is an honor to lead Norwood because it has earned such an unmatched reputation for excellence and innovation with its medical device customers. Another thing that has truly impressed me has been every employee's sacred commitment to put the patient at the center of everything they do.
